## **NEPtHA Stall and Camper Rules 2025**

- 1. No stall reservations will be accepted before April 1st.
- 2. Stalls are assigned in the order they are received. Every attempt will be made to accommodate special requests but cannot be guaranteed.
- 3. Stall & Camper Reservations form must be completely filled out with all required information or **the person listed as main contact** on the form <u>WILL BE RESPONSIBLE</u> for **the entire cost of the stall(s)**, **bedding and camper(s) listed on the form**.
- 4. Stalls/campers/trailers/tents reserved onsite at the show will be made through the show office and shall complete the stall form at the show office and shall **receive a camper pass which MUST be displayed on your camper, tent or trailer.** Stall and caper charges shall be paid with your show bill.

## STALL/CAMPER CUT OFF DATE shall be THE SATURDAY PRIOR TO THE SHOW.

- 5. ANYONE LEAVING THE SHOW FACILITY WITHOUT PAYING THEIR DEBT SHALL NOT BE ABLE TO RESERVE STALLS OR A CAMPER SPOT.
- 7. <u>CANCELLATIONS</u>: \*<u>All cancellations must be received by MONDAY BEFORE THE SHOW</u>. (5 days before the show). IF YOU FAIL TO SEND IN THE STALL CANCELATION FORM. YOU WILL BE RESPONSIBLE FOR ALL CHARGES. NO EXCEPTIONS WILL BE MADE.
- ANY CANCELLATION MADE PAST MONDAY MUST HAVE A VET OR DOCTOR NOTE/BILL ATTACHED TO THE FORM OR YOU SHALL BE RESPONSIBLE FOR ALL CHARGES.
- 8.\*\*\*Refunds: You will have 3 options:
- A. Show credit, which will be applied to your show bill.
- B. Forwarded or Applied to the next show.
- C. Check (will be sent within 2 weeks after the show)
- \*\*It is the exhibitor's responsibility to notify NEPTHA of how they would like the credit / refund applied.
- 9. NO campfires of any kind per fire marshal and town of N. Hampton.
- 10. No smoking within 15' of ANY barn or arenas!
- 11. No cooking in barns / arenas
- 12. ABSOLUTELY No altering of stalls, any size adjustments must be submitted with your stall reservation to availed a \$35.00 fee
- 13. **No staples, nails, screws in stalls.** (THREE COUNTY FAIRGROUNDS WILL CHARGE A FINE FOR ALL DAMAGES DONE to any STALLS)
- 14. **Keep barn aisles open and free of clutter**. No tack or large tables shall be stored in the aisle per N. Hampton Fire Marshall. Must have a tack stall reserved.
- 15. All extension cords and Fans must be grounded with three wire/prong plugs per Fire Marshall Orders. Clippers must have a UL approval label attached.

The use of two wire extension cords (SIP chords) will no longer be allowed on the fairgrounds for safety reasons.

- 16. ALL manure goes in barriers. **NO TRASH PLEASE**.
- 17. ALL trash to authorized dumpsters only.

- 18. NO mixing of hay or straw with shavings for bedding, no pelletized saw dust. SHAVINGS ONLY or you will be assessed a disposal fee.
- 19. NO watering the stalls.
- 20. NO horses in roped off or posted areas, \*\*YOU WILL BE HELD RESPONSIBLE AND CHARGED FOR ANY FEES INCURRED IF YOU GO INTO THESE AREAS NO EXCEPTIONS WILL BE MADE. PLEASE respect the Show Grounds.
- 21. NO one under the age of 16 is to operate a motorized vehicle or golf cart.
- 22. Parking rules will be enforced keep fire lanes open, or you will be towed. Anyone parked in the handicapped areas MUST DISPLAY A HANDICAPPED PLACARD.
- 23. **NO grey water discharge from campers**. YOU WILL BE FINED BY FAIRGROUNDS. THEY WILL BE CHECKING.
- 24. Camper & Tents: **ANYONE WHO PLUGS INTO ELECTRICITY/SEWER WILL BE CHARGED** (This includes: being plugged into the barn, to another trailer, etc.
- 25. Campers will have priority in camper spots over tents. Tents must not interfere with camper parking and hook-ups. No holding camper spots for late arrivals.
- 26. Trailers & Campers that are not hooked up to electricity or water should not park in camper spots, or you will be charged weekend camper fee.
- 27. There is a maximum limit of 2 miniatures, ponies or weanlings per stall. Horses 1 year of age or older must be stalled separately.
- 28. NO horses / ponies/ miniatures in trailers overnight.
- 29. No horses or dogs shall be left unattended in isles of the barns or arena. This will be STRICTLY ENFORCED.
- 30. ALL DOGS MUST BE LEASED EVERYWHERE ON THE SHOW GROUNDS AND UNDER CONTROL AT ALL TIMES. NO EXCEPTIONS.
  - A. All dogs on the show grounds must have proof of rabies shot.
- B. All dogs are not allowed in/or around any riding areas where exhibitors are riding, in holding pens, or left unattended in the aisles of the barn, etc.
  - C. IMPORTANT NOTICE TO ALL WITH DOGS: If the show manager receives multiple complaints about dogs...
- Ist offense will be verbal warning. 2nd offense will be a \$10 fine per dog(s) and the dog(s) will not be permitted at any NEPTHA future shows or events.
- 31. No one should be mounted on their horses in the isles of the barns.

NEPtHA appreciates you following the rules sent forth for stalling and camper sites, as these are set forth by Three County Fairgrounds or The Northampton Fire Marshal's Office in most instances.
